The calculation of the foregoing percentage was based on 49,025,918 shares of the Issuer's Common Stock outstanding as of August 19, 2019, as per the information reported in the Issuer's press release dated August 19, 2019.

Thereafter, as of the close of business on September 4, 2019, the reporting persons beneficially owned an aggregate of 2,450,649 shares of the Issuer's Common Stock or 4.8% of the Issuer's Common Stock outstanding. The calculation of the foregoing percentage was based on 50,647,539 shares of the Issuer's Common Stock outstanding as of September 3, 2019, as per the information reported in the Issuer's press release dated September 3, 2019. Specifically, as of the close of business on September 4, 2019:

- i) Integrated Core Strategies (US) LLC, a Delaware limited liability company ("Integrated Core Strategies"), beneficially owned 2,076,170 shares of the Issuer's Common Stock;
- ii) Integrated Assets II LLC, a Delaware limited liability company ("Integrated Assets II"), beneficially owned 262,857 shares of the Issuer's Common Stock; and
- iii) ICS Opportunities, Ltd., an exempted company organized under the laws of the Cayman Islands ("ICS Opportunities"), beneficially owned 111,622 shares of the Issuer's Common Stock, which collectively with the other foregoing reporting persons represented 2,450,649 shares of the Issuer's Common Stock or 4.8% of the Issuer's Common Stock outstanding.

Millennium International Management LP, a Delaware limited partnership ("Millennium International Management"), is the investment manager to ICS Opportunities and may be deemed to have shared voting control and investment discretion over securities owned by ICS Opportunities.

Millennium Management LLC, a Delaware limited liability company ("Millennium Management"), is the general partner of the managing member of Integrated Core Strategies and Integrated Assets II and may be deemed to have shared voting control and investment discretion over securities owned by Integrated Core Strategies and Integrated Assets II. Millennium Management is also the general partner of the 100% shareholder of ICS Opportunities and may also be deemed to have shared voting control and investment discretion over securities owned by ICS Opportunities.

Millennium Group Management LLC, a Delaware limited liability company ("Millennium Group Management"), is the managing member of Millennium Management and may also be deemed to have shared voting control and investment discretion over securities owned by Integrated Core Strategies and Integrated Assets II. Millennium Group Management is also the general partner of Millennium International Management and may also be deemed to have shared voting control and investment discretion over securities owned by ICS Opportunities.

Israel A. Englander, a United States citizen ("Mr. Englander"), controls the managing member of Millennium Group Management and may also be deemed to have shared voting control and investment discretion over securities owned by Integrated Core Strategies, Integrated Assets II and ICS Opportunities.

The foregoing should not be construed in and of itself as an admission by Millennium International Management, Millennium Management, Millennium Group Management or Mr. Englander as to beneficial ownership of the securities owned by Integrated Core Strategies, Integrated Assets II or ICS Opportunities, as the case may be.
